



MMA'S LEGISLATIVE POLICY COMMITTEE (LPC)

The 70-member Legislative Policy Committee (LPC), is represented by two municipal officials elected by the boards and councils in each of the State's 35 Senate Districts.

The LPC meets monthly when the legislature is in session to establish the Association's position on bills of municipal significance.

Additionally, during the fall of an even numbered year, the LPC also established MMA's two-year legislative platform, seeking changes to existing statutes. The newly elected LPC met in August in preparation for the 132nd Legislature which will convene in January 2025.

MMA'S 2024-26 LEGISLATIVE PLATFORM

At their first meeting on August 29th, the LPC voted to not only protect our core municipal issues, like revenue sharing and education funding, but to also put forward a slate of bills to improve, clarify or amend current statues that impact local government.

The LPC also voted to set up several focus groups to fine tune the platform - one group is focused on property tax reforms. These topics are some of those that will be discussed:

- Increased Homestead Reimbursements
- Split Taxation (for commercial and/or second homes)
- Tree Growth Current Use Program
- Foreclosure Process
- And many, many more.....
